GENERAL CONDITIONS CHILDREN 2022-2023

GENERAL

- Your registration for the children's Program 2022-2023 refers to the entire (rest) period until the 2nd of July 2023. You do have the option to cancel please read under: 'Cancellations'
- Children and visitors are expected to adhere to ADC's houserules
- The organization and administration of ADC communicates through email. Messages (verbal or telephone) through the teacher and / or desk staff are not processed
 - ADC cannot be held responsible for non-arrived mail, unopened mail and Incorrect email addresses.
- Please check the settings of your Spam filter so you will receive mail from ADC.
- Enrollments are non-transferrable.
- ADC cannot be held responsible for loss or theft of your personal belongings.
- ADC cannot be held responsible for injuries of students and users of our properties.
- ADC reserves the right to be closed for an "acceptable period" in the event of fire, water damage, relocation, or other unforeseen situations. In this case, no right can be derived to dissolve or suspend installment payments.
- In case ADC gets closed on Government measures, ADC will offer her classes in an alternative manner. By signing up for season 2022/2023 the client accepts this alternative service and will not give the client the right to cancel the registration 2022/2023.

FINANCIAL:

- All published class prices are monthly fees. An entire season contains 10 monthly payments.
- Holidays and days off are already settled in the total amount.
- There is a registration fee of € 15 per child/per season. Registration fee must be paid when you complete the online registration through IDEAL.
- Registration fee will not be refunded even in case of cancellation after the trial class.
- Upon entry after September 15th 2022, the first payments will be settled comparatively.
- All payments will be by direct debit from the IBAN bank account number used with the IDEAL -payment for the registration fee, around the 15th of the month.
- No refunds are offered.
- By unlawful reversal of one of the direct debit, we charge € 25, penalty fee.
- In case we have to send a 'notice of default' we charge € 15,- administration fee.
- 2 or more children from one family taking class gives a discount of 5% on the tuition fee per child.
- 2 or more classes per child gives a discount of 5% on the tuition fee per class.
- Discounts are granted at the first full monthly payment.
- In case the tuition fee will be paid by the <u>Jongeren Cultuur Fonds</u>, the online registration can only be done after you have send the email stating the tuition is awarded to saskia@amsterdamdancecentre.nl
